Cancer Council SA's Riverland Relay For Life | VIP Campsite Package Incentive Promotion

TERMS AND CONDITIONS

1. Instructions to enter the Cancer Council SA's Riverland Relay For Life 2024 (Riverland Relay) VIP Campsite Package Incentive Promotion form part of these conditions.
2. To be eligible to receive a prize, teams (Entrants) must be registered for Riverland Relay For Life 2024 and raise and bank the minimum amount required for each level before 11.59pm on Sunday, 6 October 2024. All funds raised, need to appear on the team fundraising website page by Sunday 6 October, 2024 to be eligible for their qualification.
3. Entry is automatic upon registering for Riverland Relay and based on total funds raised as at 11.59pm Sunday, 6 October 2024.
4. Registration fees are excluded from eligible team fundraising totals.
5. Direct funds banked without a reference number, and which cannot be reconciled to a registered team before 11.59pm Sunday, 6 October 2024 are excluded from entry. It is the entrant's responsibility to ensure offline funds are banked using their team's individual banking reference number and notify CCSA Relationship Officer to assign to their team website.

7. Each qualifying team will be entitled to receive the Prize based on maximum amount of funds raised as at the end of the competition period. Qualifying teams are entitled to receive one (1) Prize only.
8. The Prizes are subject to change due to supplier availability.
9. The start date of the promotion is January 1, 2024.
10. Qualification for promotion closes at 11.59pm on Sunday, 6 October 2024.
11. The prize will be awarded to the Team Captain & Team named in the entry. However, in the event of a dispute, the prize will be awarded to the email account holder of the entry mechanism used to submit the Entrant's entry.
